And the said Mortgagor agree to insure the house and buildings on said lot in a sum not less than Thirteen hundred (\$1300.00)

Dollars (in a company or companies satisfactory to the mortgage...), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said Mortgagee..., and that in the event that the mortgagor... shall at any time fail to do so, then the said mortgagee... may cause the same to be insured in his name and reimburse himself, the said mortgagee
