

TOGETHER with, all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said Premises unto the said Board of Trustees of Presbyterian College of South Carolina, A. C. Spencer Treasurer and Assigns, forever. And I myself, my Heirs, Executors and Administrators, to warrant and forever defend, all and singular the said premises unto the said Board of Trustees of Presbyterian College of South Carolina, A. C. Spencer Treasurer and Assigns, from and against me and my Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same, or any part thereof.

And the said Mortgagor agree to insure the house and buildings on said lot in a sum not less than Dollars (in a company or companies satisfactory to the mortgage), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said Mortgagee, and that in the event that the mortgagor shall at any time fail to do so, then the said mortgagee may cause the same to be insured in name and reimburse for the premium and expenses of such insurance under this mortgage, with interest.
