SEND GREETING:

WHEREAS, I, the said Ruth P. Laine
 in and by my certain promissory note in writing, of
 even date with these presents, am well and truly indebted to
 Sophie B. Meares
 in the full and just sum of Twenty-two Hundred fifty + no/100 (\$3250.00) Dollars,
 to be paid Twenty-five (\$25.00) dollars on the tenth day of each
 month, commencing October 10, 1935 and continuing in
 monthly succession until September 10, 1938 when the
 balance will be payable. Such \$25.00 to pay both interest
 and principal September 10, 1935, at the rate of six (6) per cent. per annum, to be
 computed and paid monthly out of each \$35.00 instalment
 until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of
 principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the
 holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee.

Ten (10%) per cent. besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as part thereof, if the same is placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the

 do grant, bargain, sell and release unto the said Sophie B. Meares

All that certain piece, parcels and lot of land

 Beginning at an iron pin on the West side
 of Elizabeth Street which point is the intersection of the south line
 of Elizabeth Street with the North line of Barrony
 Street and running thence along the West line
 of Elizabeth Street N. 12-36 E. fifty feet to an iron
 pin; thence N. 69-13 W. one hundred fifty-five
 and two-tenths feet to an iron pin; thence S.
