WHEREAS, *I*, the said *E. Mack Gillespie*,
in and by *my* certain *promissory* note in writing, of
even date with these presents, *am* well and truly indebted to

Lewis G. Prince, Committee
in the full and just sum of *Seven Hundred fifty and no/100 (\$752.00)* Dollars,
to be paid *one year from date*

with interest thereon, from *date*, at the rate of *7* per cent. per annum, to be
computed and paid *semi-annually*
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the
holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

a reasonable amount besides all costs and expenses of collection, to be
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said
debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the
the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That *I*, the said *E. Mack Gillespie*,
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of *Three* Dollars, to

in hand well and truly paid by the said *Lewis G. Prince, Committee*
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents
do grant, bargain, sell and release unto the said *Lewis G. Prince, Committee*,

*All that piece, parcel or lot of land in the
County and State aforesaid, situate on the
Jones Gap Road (now Keel Highway) and in
the northwest section of the town of Marietta
and on Beaver Dam Branch, waters of north
Saluda River, adjoining the lands now or formerly
Mrs. Rizzie Cleveland Pritchett, and fronting on
said Jones Gap Road, approximately 1,000 feet,
containing 10 acres, more or less, on which is
situated a six room dwelling, barn, store room
and filling station.*
