WHEREAS, I, the said Ernestine L. Leatherwood  
in and by my certain promissory note in writing, of  
even date with these presents, am well and truly indebted to

Sadie E. Davis  
in the full and just sum of Eight Hundred (\$800.00) Dollars,  
to be paid five (5) years after dated

with interest therefrom at the rate of six per cent. per annum, to be  
computed and paid monthly until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of  
principal or interest be at any time past due and unpaid then the whole amount evidenced by said note to become immediately due, at the option of the  
holder hereof, who may thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per  
cent of \$200 besides all costs and expenses of collection, to be  
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said  
debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the  
the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I the said Ernestine L. Leatherwood  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

Sadie E. Davis  
according to the terms of the said note, and also in consideration of the further sum of three Dollars, to me  
the said Ernestine L. Leatherwood

in hand well and truly paid by the said Sadie E. Davis  
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents  
do grant, bargain, sell and release unto the said Sadie E. Davis, and her heirs

and assigns forever, all and singular that  
certain piece, parcel, lot or tract of land  
situate, lying and being in Greenville County,  
Greenville Township, State aforesaid, near  
the Augusta Road School on Highland  
Drive, and being known as Lot #44 of the b.  
B. Martin subdivision shown on plat of  
record in Plat Book 102, page 102, and having  
according to said plat the following metes and  
bounds, to-wit:

Beginning at an iron pin on the north  
side of Highland Drive, corner of Lots 43 and  
44 and running thence N. 48-50 E. 180 feet to an  
iron pin, joint corner of Lots 43, 44, 23 and  
34; thence N. 41-10 W. 82 1/2 feet to iron pin, joint  
corner of Lots 44, 45, 22 and 23; thence S. 48-50  
W. 180 feet to an iron pin on Highland Drive;  
joint corner of Lots 44 and 45; thence S. 41-10  
E. 82 1/2 feet to the beginning corner.

This being the same lot of land conveyed  
to Ernestine L. Leatherwood by deed dated August  
16th, 1935, by L. A. Meyers and Sadie Davis.

It is understood and agreed that  
this mortgage is junior in lien to the mortgage  
of Ernestine L. Leatherwood to Home Owners  
Loan Corporation dated August 21st, 1935, in  
the sum of \$3197.77, and is not to be foreclosed  
in any event for a period of five (5) years.

For Value Received, I do hereby transfer, set over and assign the  
within mortgage, and the note which it secures, unto D. B. Leatherwood,  
without recourse, this 28th day of November, 1940.
