WHEREAS, *I*, the said *Mamie M. Guy*
in and by *my* certain *Promissory* note in writing, of

in the full and just sum of *Six Thousand* Dollars,

to be paid *\$150.00* every consecutive six months for two
and a half years and the remainder at the end
of three years from date, with the privilege to, at
any interest paying period, anticipate said note,
or any part thereof, in multiples of *\$1000.00*
with interest thereon, from *date until paid*, at the rate of *6* per cent. per annum, to be
computed and paid *Semi-annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the
holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of
