principal of interest *is not paid* when due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the  
holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *36*

added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said  
debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents  
do grant, bargain, sell and release unto the said

*L. L. Turner and Lula Turner*, their heirs and  
assigns *36*

All that certain piece, parcel or tract of  
land situated *in Chick Springs* and being in *Chick Springs*  
Township, *Greenville* County aforesaid, and  
having the following metes and bounds, to wit:  
Beginning *at* an iron pin on *Paris Mountain*  
Road, at *the* of other lands owned by *Edward*
