SEND GREETING:

WHEREAS, *we*, the said *N. E. Chapman and R. L. Chapman*
in and by *our* certain *promissory* note in writing, of
even date with these presents, *are* well and truly indebted to

South Carolina National Bank
in the full and just sum of *Eight Hundred (\$800.00) P.M.* Dollars,
to be paid *on or before February 1, 1934* payable at the
rate of \$50.00 every three months

with interest thereon, from *the date hereof*, at the rate of *6* per cent. per annum, to be
computed and paid *quarterly*

until paid in full, and interest not paid when due to bear interest at the same rate as principal; and if any portion of
principal or interest be at any time not paid, the whole amount evidenced by said note to become immediately due, at the option of the
holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

10 c/o besides all costs and expenses of collection, to be
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said
debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the
the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That *we* the said *N. E. Chapman and R. L. Chapman*
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

South Carolina National Bank
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *us*
the said *N. E. Chapman and R. L. Chapman*

in hand well and truly paid by the said *South Carolina National Bank*
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents
do grant, bargain, sell and release unto the said *South Carolina National Bank*

All that certain piece, parcel or lot of land
situate, lying and being in the County and State
aforesaid, on the north side of Green Avenue,
in the 5th ward of the City of Greenville at the in-
tersection of Green Avenue and Markley Street.

Beginning at the corner of McRay lot, now Griffin
lot, on Markley Street, thence along Markley Street
in a southerly direction 45.7 feet to the intersection
of said street and Green Avenue, thence along
Green Avenue 150.2 feet to the corner of the Mitchell
lot, thence along the line of the Mitchell lot 167
feet to the corner of the McRay or Griffin lot on
the Donaldson line, thence along the line of the
McRay or Griffin lot 108.5 feet to the beginning
corner.
