Union Trust Company of Maryland, Baltimore, Maryland, and American Land and Investment Company, (formerly American Bank and Trust Company), Greenville, South Carolina, Trustees in the deed of trust hereinafter set forth, in consideration of the debt thereby secured having been fully paid and satisfied, do hereby release the lien of a certain deed of trust made by John E.
