SEND GREETING:

in and by my certain proprietary well and truly indebted to  
note in writing, of even date with these presents, am George Norwood as Conservator of The Peoples Building & Loan Association,  
in the full and just sum of

Dollars, to be paid \$25.00 at each interest

with interest thereon from September 30, 1936 at the rate of 6 per cent. per annum, to be  
computed and paid March 1 and September 1 of each year

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at  
any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon  
and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it  
should be deemed by the holder thereof necessary for the protection of his interest to place, and the holder should place, the said note or this mortgage in the hands  
of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of  
the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Greenville  
County, State of South Carolina, known as Lot no.  
B, in a subdivision of Lot no. 56 as shown on  
plat of property of Loper-Town, said plat re-  
corded in Plat Book "F" at Page 77 said Lot B-56  
having the following courses and distances:

Beginning at a stake on the north side of  
Gordan Street 485 feet from the Old White Horse  
Road, corner of Lot 56 b, running thence with line  
of Lot 56-b N. 10-15 W. 200 feet; thence S. 79-45 W. 50  
feet to an iron pin, corner of Lot 56 a; thence  
with line of Lot 56-a S. 10-15 E. 200 feet to iron  
pin on Gordan Street; thence with Gordan Street  
N. 79-45 E. 50 feet to the beginning.
