Dollars, to be paid in monthly installments of Seventy & 50/100 each  
beginning on the 10th day of April, 1913 and a like amount  
thereafter on the 10th of each full previous month until paid  
in full.

with interest thereon, from date at the rate of 7% per cent. per annum to be  
computed and paid Annually

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of  
principal or interest be at any time past due and unpaid then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

10% besides all costs and expenses of collection, to be  
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will  
more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell  
and release unto the said Mrs Laurie Vance Norwood,

All that certain piece, parcel or lot of land situate in the  
County and State aforesaid, beginning at a pin on the south-  
west side of Birnie Street which pin is 168 ft. northwest  
from the intersection of main Street and Birnie Street and  
running thence along Birnie Street N. 59-30 W. 119.5 ft. to pin;  
thence S. 32-10 W. 194 ft. to fence post; thence S. 27 E. 140 ft. to  
pin on the north side of main Street; thence along main  
Street N. 63-30 E. 175 ft. to pin near Culvert; thence N. 36-15 W.  
125 ft. to pin on ditch; thence N. 49-30 E. 76 ft. to the point of  
beginning.
