its successors Heirs and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in Greenville Township, Greenville County, State aforesaid,

Western corner of Grove Road and Chapman Street, near the city of Greenville, and being shown as Lot no. 26 on plat of "Mills Avenue Highlands" property of Piedmont Corporation, made by Dalton + Neres, in May, 1937, and having the following metes and bounds:

Beginning at a stake at the western corner of Grove Road and Chapman Street, and running thence with the western side of Chapman Street, N. 00-11 W. 36 feet to corner of Lot no. 27; thence with the line of said lot N. 64-40 W. 222.4 feet to a stake at corner of Lot no. 9; thence with the line of said lot, S. 23-37 W. 25 feet to a stake, corner of Lot no. 25; thence with the line of said lot, S. 42-00 E. 79.5 feet to a stake; thence still continuing with the line of Lot no. 25; S. 62-36 E. 163 feet to a stake on Grove Road, thence with the north-western side of Grove Road, N. 27-24 E. 29 feet to the beginning corner, and being the same property conveyed to J.
