TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Eleanor V. Boynton and Loan, S.C. SEND GREETING:

in and by my certain promissory note, in writing, of even date with these presents, well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Eight Hundred + no/100 (\$1,800.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Ninetyeight and no/100 (\$98.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by any attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That Eleanor V. Boynton, the said

C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in the City of Greenville, on the south side of Sindal Avenue, and being better known and designated as Lot no. 29, in Block B, of the Eagle Park subdivision, as shown on Plat of record, in Plat Book 6, Page 238, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Sindal Avenue, joint corner of Lots 28 and 29, and running thence with the joint line of said Lots, S. 0-53 E. 185.6 feet to an iron pin in line of Lot 17; thence N. 77-44 W. 62.6 feet to an iron pin, rear corner of Lots 29 and 30; thence with the joint line of said Lots 29 and 30, N. 0-55 W. 171.4 feet to an iron pin on Sindal Avenue; thence with Sindal Avenue, N. 89-07 E. 61 feet to the beginning corner. Being the same lot conveyed to me by J. C. Garber and W. D. Parrish, March 6, 1923, by deed recorded in the R. M. C. office for Greenville County in Vol. 88, page 146.

"All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the north side of West Earle street, and having the following metes and bounds, to-wit:

Beginning at a stake on West Earle street at a point 250 feet east of Townes street, and running thence with Earle Street, S. 84 1/2 E. 50 feet to corner of Lot N; thence with line of said lot, N. 5 1/2 E. 200 feet to a stake; thence N. 84 1/2 W. 50 feet to a stake, rear corner of Lot L; thence with line of that lot, S. 5 1/2 W. 200 feet to the beginning corner. Said lot is shown on plat of lands of the Mountain City Land + Improvement Co., recorded in Vol. 24 24, page 605, and being known and designated as Lot M, on map 6 and is the same lot conveyed to me by Esther Coas by deed dated April 14, 1937, and not yet recorded, this mortgage being given to secure the unpaid portion of the purchase price thereof.
