TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, *I* the said *H. W. Jordan* SEND GREETING:
H. W. Jordan

in and by *my* certain promissory note, in writing, of even date with these presents, *am* well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of *One Thousand and no/100* (\$1,000.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of *Ten and no/100* (\$10.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That *I*, the said *H. W. Jordan*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to *me* the said *H. W. Jordan*

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. Good as shown by Plat thereof as recorded in the R. M. C. Office for Greenville County in Plat Book 4, Page 223, containing one acre, more or less, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of National Highway no. 29, at corner of Lots 6 and 7, and running thence along the line of said lots, S. 70-30 E. 315 feet to an iron pin in line of said lots; thence approximately N. 19-25 E. 190 feet to an iron pin; thence N. 70-30 W. 315 feet to an iron pin on the east side of said National Highway; thence along the line of said Highway, S. 18-21 E. 100 feet to the beginning corner and being the same plat of land conveyed to me by Cabvall Land Co. deed dated April 2, 1935 and recorded in the R.
