Lien Agreement For Necessary Repairs

Secures mortgagor's obligation for \$3888.51 and interest and covers lands therein described.

The undersigned, owners of the real property covered by the lien of the above described mortgage, hereby acknowledge that repairs necessary to maintain and preserve the improvements upon said property have been made and completed, and that the costs of such necessary repairs \$161.50 Dollars (\$161.50), has been advanced by the Home Owners' Loan Corporation to the undersigned, the receipt of which sum is hereby acknowledged, and which said sum, with interest thereon, the undersigned bind and obligate themselves to pay as below set out.

It is understood and agreed that the said sum has been advanced under the terms and provisions of the above described mortgage, in payment for repairs necessary to maintain and preserve the improvements upon said property, and the amount of said advance, with interest thereon, is a part of the principal debt secured by the said mortgage, is fully secured hereby, and subject to all of its covenants and provisions applicable thereto. The undersigned hereby bind and obligate himself/themselves to pay to the Home Owners' Loan Corporation on demand the sum of \$161.50, but until demand is made to pay the sum of \$3.05 monthly, beginning on the 8th day of February, 1937, and on the 8th day of each month thereafter until the amount of such advance with interest thereon has been paid in full.

If for any reason or at any time it shall be held that the mortgage aforesaid does not secure the amount of this advance, then the undersigned hereby give and grant to the Home Owners' Loan Corporation, its successors or assigns, an additional valid lien on said property and improvements to secure said sum, with interest thereon, at the rate which the original note or bond secured by the aforesaid mortgage bears.

The undersigned hereby acknowledge and agree that they do not have and will not assert or claim any defenses, offsets, counterclaims, or equities against the payment of the aforesaid sum, together with interest hereon as above specified, or against the validity of the lien securing the same or the enforcement thereof.

This instrument shall bind the heirs, executors, administrators and assigns of the undersigned.
