I, J. R. Coleman, of Greenville County, South Carolina SEND GREETING:WHEREAS, I the said J. R. Colemanin and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Bates Township, containing 8-1/8 acres, more or less, bounded by lands of J. E. Coleman, E nonee Creek and Buncombe Road, and being more particularly described as follows:
