All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, just outside the corporate limits of the City of Greenville on Alexander Street, known as part of Lot 5 on plat of property of Canton West, plat recorded in R. M. C. Office for said county in Plat Book H, page 44, and having the following courses and distances:

Beginning at a stake on the South side of Alexander Street 58 feet from the corner of Lot No. 6, as shown on said plat and running thence S. 32-30 E. 83 feet to stake on line of Henry Briggs; thence with line of Henry Briggs S. 57-30 W. 42 feet to iron pin, corner of Lot No. 4; thence with line of said lot N. 32-30 W. 83 feet to iron pin on Alexander Street; thence with said street 42 feet to the beginning corner, being a portion of the premises heretofore conveyed to Minnie C. Briggs by Fannie C. Scott, Judge of Probate for Greenville County, dated October 18, 1929, recorded December 3, 1929, in the R. M. C. Office for Greenville County in Deed Book "110", at page 388.
