I, M. Thomas Anderson SEND GREETINGS:

Whereas, I the said M. Thomas Anderson  
in and by MY certain PROMISSORY note in writing, of even date with these presents, am  
well and truly indebted to Guy B. Foster

in the full and just sum of Three Thousand, Seven Hundred, Fifty and No/100  
(\$3,750.00) Dollars, to be paid  
ninety days after date at any Bank in Greenville, S. C.

with interest thereon from maturity at the rate of 6 per centum per annum to be computed and paid quarterly

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Guy B. Foster, his heirs and assings forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, about two miles southeast of the City of Greenville, lying east of the Laurens Road, and being known and designated as Lot No. 203 on plat of East Lynne Addition, and having, according to said plat which is recorded in the R. M. C. office for Greenville County in Plat Book H, page 220, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Sycamore Drive at the joint corner of Lots 202 and 203, and running thence with the joint line of said Lots S. 69-42 E. 189.5 feet to an iron pin; thence with the joint rear line of Lots 203 and 206, S. 14-13 W. 50.3 feet to an iron pin; thence with joint line of Lots 203 and 204, N. 69-42 W. 194.7 feet to an iron pin on the east side of Sycamore Drive; thence with the east side of said Drive, N. 20-18 E. 50 feet to the beginning corner.
