TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Ethel M. King SEND GREETING:

WHEREAS, I the said Ethel M. King

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of FOUR THOUSAND SIX HUNDRED FIFTY (\$ 4,650.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of FORTY FIVE AND NO/100

(\$45.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, the said Ethel M. King

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, just outside the corporate limits of the City of Greenville, on the East side of Grove Road, known and designated as Lots Nos. 63 and 64 on Plat of Cherokee Land Company, recorded in the R. M. C. Office for Greenville County in Plat Book C, page 96, and being fully described as follows:

BEGINNING on the East side of Grove Road 187 feet 6 inches from the corner of Gatechee Road and Grove Road, and running thence with Grove Road S. 18-48 W. 120 feet and 6 inches to corner of Lot No. 62; thence with line of Lot No. 62 S. 63-32 E. 173 feet to a 15 foot alley; thence with said alley N. 27-28 E. 120 feet to corner of Lot No. 63; thence along line of Lot No. 65 N. 63-32 W. 193 feet to the point of beginning.
