TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, J. Wilbur Hicks

SEND GREETING:

WHEREAS, I the said J. Wilbur Hicks

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Two Thousand Three Hundred

(\$2,300.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Twenty-Three and No/100

(\$ 23.00 Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, the said J. Wilbur Hicks

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said J. Wilbur Hicks in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

In Greenville Township, in West Greenville, on the South side of a 12 foot alley leading Eastward from Bob Street, and having the following courses and distances, according to survey made by C. H. Millard, Engineer, April 1924.

BEGINNING at an iron pipe on the East side of Bob Street, in center of a 12 foot alley, which pipe is also the corner of property of Alice Smith, and running thence with Bob Street S. 22-45 W. 135 feet to iron pipe; thence S. 67-30 E. 106.5 feet to iron pipe, corner of lot heretofore conveyed to Frank N. Ellis; thence with his line N. 22 E. 135.02 feet to iron pipe in the center of 12 foot alley; thence with the center of said alley N. 67-30 W. 105 feet to the beginning.

The above is the same lot of land conveyed to me by the Fidelity Federal Savings and Loan Association by its deed of even date, yet to be recorded, and the within mortgage is given to secure the balance due on the purchase price.
