with interest thereon from date at the rate of 7% per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Elizabeth H. Carnes:-

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 77 on plat of property of West End Land and Improvement Company, and having, according to said plat which is recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book A, page 153, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the East side of Palmetto Avenue, which pin in 318.6 feet South from the intersection of Palmetto Avenue and Haynie Street and at the joint corner of lots 77 and 78, and running thence with the joint ~~corner of~~ line of said lots N. 79 E. 87 feet to an iron pin on the West side of Chapin Street; thence with the West side of Chapin Street S. 14-10 E. 50 feet to an iron pin, joint rear corner of lots 76 and 77; thence with the line of said lots S. 79 W. 90 feet to an iron pin on the East side of Palmetto Avenue; thence with the East side of Palmetto Avenue N. 11-00 W. 50 feet to the point of beginning.
