

MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, (Mrs) Catherine Miller SEND GREETING:

WHEREAS, I the said (Mrs) Catherine Miller

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

FOUR THOUSAND AND NO/100

(\$ 4,000.00 Dollars, with interest at the rate of (6%) per centum, per annum, to be repaid in installments of

FORTY AND NO/100

(\$ 40.00 ) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I the said (Mrs) Catherine Miller

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to

the said (Mrs) Catherine Miller

in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situated lying and being in the State of South Carolina, County of Greenville.

and in Greenville Township, about three miles northwest of the City of Greenville, and being known and designated as Lot No. 5, of a resubdivision of Lots 22, 23 and 24 of Geer property, as shown on plat not yet recorded of the property of R. S. Ballenger on Blue Ridge Drive, according to a survey made by Dalton & Neves, Sept. 1937, and having the following metes and bounds, to-wit:

"BEGINNING, at an iron pin on the southwest corner of Blue Ridge Drive and an unnamed Street, and running thence S. 6-13 E. 180 feet to an iron pin; thence S. 84-0 W. 59 feet to an iron pin, at the corner of Lot 4 and 5; thence N. 6-13 W. along the line of lots 4 and 5, 180 feet to an iron pin on Blue Ridge Drive; thence N. 84-0 E. along Blue Ridge Drive, 59 feet to the beginning corner, said lot being a portion of Lot No. 24 of the property of B. E. Geer as shown on plat thereof recorded in the R. M.C. office for Greenville County in Plat Book G, page 133, and being the same lot conveyed to me by R. S. Ballenger by deed dated Sept. 22, 1937, and recorded in the R. M. C. office for Greenville County in Vol. 197, page 272."
