in the full and just sum of Five Hundred and no/100
(\$ 500.00) Dollars, to be paid
one year from date

with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid
semi-annually until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to
become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should
be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection
of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either
of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mort-
gage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being on the East side of Elizabeth Street, in subdivision known as North Hills and known and designated as Lot "E", as shown on plat of said sub-division recorded in Plat Book H, Page 90.

BEGINNING at an iron pin on the East side of Elizabeth St. at a point 210 feet from Garreaux Street and thence running S. 65.17 E. 144.3 feet to iron pin; thence N. 16-45 E. 50 feet to an iron pin at rear corner of lot "D"; thence along said lot N. 65.17 W. 146.8 feet to an iron pin; thence along Elizabeth Street S. 13.12 W. 50 feet to the point of beginning.
