On or before October 1, 1949, we, the undersigned Trustees of Fork Shoals School District No. 2 B, Greenville County, promise to pay to The Treasurer of Greenville County, or order, the sum of Three HUNDRED SEVENTY -FIVE DOLLARS, value received, with interest thereon from date at the rate of Four per cent per annum, to be computed and paid annually until paid in full; all interest not paid when due to bear interest at the same rate as the principal; this being money borrowed from Greenville County for the sole purpose of purchasing building sites, and constructing and equipping school buildings for school purposes, under Act No. 1225 of the General Assembly of 1938, and to secure the payment of the said sum with interest, the taxes of said school district to be levied and collected and applicable to the payment of this sum and interest are hereby pledged to the payee hereof, or order.

It is hereby certified and recited that each and every act, condition and thing required to be done, happened and performed precedent to and in the issuance of this note has been done, happened and been performed in full and strict compliance with the terms of said Act No. 1225 of the General Assembly of 1938, and that this note is within the statutory limit authorized to be borrowed for such purpose.
