TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Robert L. Martin, of Greenville, S. C. SEND GREETING:

WHEREAS, I the said Robert L. Martin

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

ONE THOUSAND AND NO/100

(\$ 1,000.00 Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

TEN AND NO/100

(\$ 10.00 ) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which are secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I the said

Robert L. Martin

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said Robert L. Martin in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

and in Greenville Township, and being known and designated as all of Lot No. 14, of Block E, of a subdivision known as "Park Place" as shown by plat thereof recorded in the R. M. C. office for Greenville County in Plat Book A, at page 119, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Fourth Street, joint corner of Lots 12 and 13, of Block E, which point is 210 feet east of First Avenue, and running thence along the line of said Fourth Street, N. 89-45 E. 75 feet to an iron pin, which point is 25 feet west of the joint corner of Lots 14 and 15; thence in a line parallel with line of lot 15, N. 0-17 E. 200 feet, more or less to an iron pin; thence N. 36-00 W. 129.7 feet, more or less, to an iron pin at joint rear corner of Lots 13 and 12; thence along the joint line of said lots, S.0-17 W. 313.7 feet to the beginning corner. Lot No. 13 being the same lot conveyed to me by Chas. W. Hopkins by deed dated Feb. 26, 1909 and recorded in the R. M. C. office for Greenville County in Vol. 6, page 312, and one-half Lot No. 14 being a portion of the same lot conveyed to me by Chas. W. Hopkins by deed dated Oct. 23, 1908 and recorded in the R. M. C. office for Greenville County in Vol. 6, page 311."
