TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Fannie B. Hand, of Greenville, S. C., SEND GREETING:

WHEREAS, I the said Fannie B. Hand

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

FIVE THOUSAND, FIVE HUNDRED AND NO/100

(\$ 5,500.00 Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

FIFTY-FIVE AND NO/100

(\$ 55.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That me the said Fannie B. Hand

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to

"BEGINNING at an iron pin on the north side of Ackley street, joint corner of Lots 37 and 38, and running thence along the joint line of said lots, N. 28-23 W. 208.3 feet to an iron pin; thence S. 61-37 W. 112.3 feet to an iron pin; thence S. 21-49 E. 204 feet to an iron pin on north side of Ackley street; thence along the line of said Ackley street, N. 64-06 E. 133.1 feet to the beginning corner."

"BEGINNING at an iron pin on the south side of Rhodes street, joint corner of Lots 19 and 20, and running thence along the line of said Rhodes street, N. 61-37 E. 60 feet to an iron pin, corner of Lots 18 and 19; thence along the line of said lots, S. 28-23 E. 212 feet to an iron pin; thence S. 61-37 W. 60 feet to an iron pin, rear corner of Lot No. 20; thence along the line of that lot, N. 28-23 W. 212 feet to the beginning corner."
