

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

And ~~X~~ **We** do hereby agree to pay all taxes and other public assessments against this property on or before the first day of January of each calendar year, and to exhibit the tax receipts at the offices of the ~~XXXX~~ **Woodruff** FEDERAL SAVINGS AND LOAN ASSOCIATION, ~~OF~~ ~~XXXXXX~~ immediately upon payment, until all amounts due under this mortgage have been paid in full, and should ~~X~~ **We** fail to pay said taxes and other governmental assessments, the mortgagee may, at its option, pay same and charge the amounts so paid to the mortgage debt, and collect same under this mortgage, with interest.

And it is hereby agreed as a part of the consideration for the loan herein secured, that the mortgagor ~~S~~ shall keep the premises herein described in good repair, and should ~~X~~ **We** fail to do so, the mortgagee, its successors, or assigns may enter upon said premises, make whatever repairs are necessary, and charge the expenses for such repairs to the mortgage debt and collect same under this mortgage, with interest.

~~And it is further agreed that I~~ shall not further encumber the premises hereinabove described, nor alienate said premises by the way of mortgage or deed of conveyance without consent of the said Association, and should ~~I~~ do so said Association may at its option declare the debt due hereunder at once due and payable, and may institute any proceedings necessary to collect said debt.
