All that certain piece, parcel or lot of land situated, lying and being in the State and County aforesaid, Chick Springs Township, about one-half mile North of Greer, on the West side of Pine Street Extension, and being a part of Tract No. 9 as shown on plat of the J. B. Burnett Estate, said plat prepared by H. S. Brockman, Surveyor, January 24, 1938, and having the following metes and bounds, to-wit:-

BEGINNING at a point in the center of the Pine Street Extension, Tom Moon and Haskell Burnett corner, and runs thence with the center of the said Street S 4-50 W 234 feet to a point in the center of said Street; ( I. P. on West bank of Street); thence S 89-00 W. 357 feet to an I. P. on the East bank of branch; thence down the branch and crossing to the West bank N 17-05 W 98.3 feet to an iron pin; thence S 85-45 W 216 feet to an iron pin on the R. L.
