We, L. V. Hudson and Melda Hudson, of Greenville County, South Carolina, SEND GREETINGS:

WHEREAS we the said L. V. Hudson and Melda Hudson,

in and by ~~my~~ OUR certain promissory note, in writing, of even date with these presents, ~~we~~ are and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of Fifteen Hundred & no/100 (\$1500.00) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Fifteen & no/100 (\$15.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum with interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That we the said L. V. Hudson and Melda Hudson,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to ~~pay~~ us the said L. V. Hudson and Melda Hudson,

in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. in Greenville Township, on the East side of North 4th Avenue, near the City of Greenville, being known and designated as Lot No. 40 of the West Property, and having, according to survey made by R. E. Dalton, C. E., in October, 1939, the following metes and bounds, to-wit:

Beginning at an iron pin on the East side of North 4th Avenue, at corner of Lot No. 39, which point is 292.5 feet North from the Easley Bridge Road, and running thence with the line of Lot No. 39, N. 73-10 E. 128 feet to an iron pin; thence N. 16-50 W. 67.5 feet to an iron pin at corner of Lot No. 41; thence with the line of said lot, S. 73-10 W. 128 feet to an iron pin on North 4th Avenue; thence with the Eastern side of North 4th Avenue S. 16-50 E. 67.5 feet to the beginning corner; being the same property conveyed to L. V. Hudson and Melda Hudson by Mabel W. White, et al., by deed dated September 6, 1939, and recorded in the R. M. C. Office for Greenville County in Book of Deeds "215" at page 26.
