WHEREAS, the Mortgagor is well and truly indebted unto Bank of Greenwood, Greenwood, S. C.

, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Thirty-Five Hundred & No/100 Dollars (\$ 3,500.00). with interest from date at the rate of four and one-half (4 1/2 %) per annum until paid, said principal and interest being payable at the office of Bank of Greenwood in Greenwood, S. C. or at such other place as the holder of the note may designate in writing, in monthly installments of Nineteen & 46/100 Dollars (\$ 19.46), commencing on the first day of February, 19 40 and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 19 65.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the Southwest side of Laurens Road (also known as U. S. Highway No. 76), near the City of Greenville, in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 12 on plat of property of Sinking Fund Commission, School District 17-A, made by C. M. Furnish, Engineer, April, 1933, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book H, at page 219, and having, according to a recent survey made by R. D. Dalton, Engineer, December 19, 1939, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southwest corner of the intersection of Webster and Laurens Roads, running thence with the Northwest side of Webster Road, S. 36-39 W. 28.1 feet to an iron pin on said Webster Road; thence continuing with Webster Road, S. 52-18 W. 171.8 feet to an iron pin on said Webster Road; thence N. 55-35 W. 45.5 feet to an iron pin; thence with the line of Lot No. 10, N. 34-25 E. 191.8 feet to an iron pin on the Southwest side of Laurens Road; thence with the Southwest side of said Laurens Road, S. 55-35 E. 99.7 feet to the beginning corner.

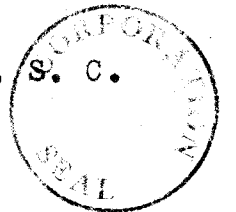
