All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, on the West side of Trade Street in the Town of Greer and being the same lot of land conveyed to me by Jessie Jones et al by deed dated October 12, 1939, and having the following metes and bounds, to wit:-
