BEGINNING at a stake in the center of the road in line of land now or formerly owned by Piedmont Corporation and running thence along line of said Corporation S. 75-40 E. 625.3' to an iron pin; thence continuing along line of said Corporation S. 73-10 E. 573.7' to a stake; thence continuing with the line of said corporation B. 16-40 W. 737.5' crossing a branch to a point; thence along line of other property owned by the grantor N. 72-25 W. crossing a branch 45' to a point; thence N. 18-30 W. 379' to a stake; thence N. 72 W. 1113' to a stake in center of said Road; thence along center of said Road N. 49-30 E. 320' to the point of beginning; and containing ten acres, more or less.
