BEGINNING at a point on the south side of Choice Ave. 100 feet east of Brier Street, and running thence along said Choice Ave. in a easterly direction 50 feet to a corner; thence in a southerly direction 100 feet; thence in a westerly direction 40 feet, more or less, to a corner; thence in a northerly direction 100 feet to the beginning corner, bounded on the north by said Choice Ave., on the east by Cleveland land, on the south by Henry Brier lot, and on the west by James lot.
