B. Lee, Trustee for the heirs of W. B. Harrison, made by Dalton & Neves, November, 1934; recorded in the R. M. C. Office for Greenville County in Plat Book "H" at page 262, and when described together having the following metes and bounds: Beginning at a point on Boyce Spring Avenue 275 feet from the corner of lot at Boyce Spring Avenue and Cleveirvine Avenue, and running thence South 410 21' East 245 feet to corner of lots now or formerly owned by Mrs. M. W. Goldsmith; thence with the line of said lots North 470 24' East 25 feet; thence continuing with the line of said lots South 410 08' East 132 feet: South 86° 13' East 155 feet; South 66°33' East 325 feet, and South 21°05' West 136.5 feet to Hillside Avenue; thence with the northern side of Hillside Avenue South 64053' East 137.2 feet to Haviland Avenue; thence with the north side of Haviland Avenue North 59012' East 178 feet; thence continuing with the curve of Haviland Avenue, the chords being North 31°55' West 183 feet and North 14°36' East 243.7 feet, to corner of lot now or formerly owned by L. B. Lips comb; thence with the line of said lot, and continuing with the line of lot now or formerly owned by W. B. Harrison North 59050! West 501.7 feet to Boyce Spring Avenue: thence with the East side of Boyce Spring Avenue South 740 West 56 feet; South 71°30' West 280 feet; thence South 76°West 165 feet to the beginning corner. Sheppard: thence with the line of said lot South 17030' East 142.5 feet to Washington Road; thence with the North side of Washington Road North 86030: East 50 feet to the point of beginning: being the same premises conveyed to Home Owners! Loan Corporation by E. Inman, Master for Greenville County, by deed dated January 12, 1938, recorded in the Office of the R. M. C. for Greenville County, S. C.
