On the Southwest corner of King Street and Valley Street and being known and designated as Lot No. 19 of West View Heights of the Pride and Patton Land Company as shown on plat of same recorded in R. M. C. Office for Greenville County in Plat Book "G" at page 33, and having the following metes and bounds, to-wit:
