Whereas, I the said Mrs. Pearle G. Dean

in and by my certain promissory note in writing, of even date with these presents, am

well and truly indebted to Bank of Greer, Greer, S. C. as Trustee for Nelle C. Black

in the full and just sum of Twenty-one Hundred Dollars

(\$ 2100.00) Dollars to be paid as therein stated

with interest thereon from date at the rate of six per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

Bank of Greer, Greer, S. C. as Trustee for Nelle C. Black

All that certain piece, parcel or lot of land situate, lying and being on the South side of East McBee Avenue, in the City of Greenville, State and County aforesaid, having the following measurements:-

Beginning at an iron pin on the South side of East McBee Avenue, at an alley, and runs thence with said East McBee in an eastern direction 41 feet to a pin; thence in Southern direction 50 feet to a pin; thence in an eastern direction 30 feet to a pin; thence in a southern direction 10 feet to a pin; thence West 71 feet to a pin on an alley; thence with said alley 70 feet to the beginning corner. This is one of the lots purchased from the H. H. Griffin Estate, see Deed Book 213, page 4, in R. M. C. Office for Greenville County.
