I, Dovie Long Moss

Whereas, I the said Dovie Long Moss
in and by MY certain promissory note in writing, of even date with these presents,
well and truly indebted to R. K. Taylor

in the full and just sum of Twenty-Five Hundred and no/100
(\$ 2,500.00) Dollars, to be paid sixty (60) days from date

with interest thereon from maturity at the rate of six per centum per annum to be computed and paid quarterly

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

R. K. Taylor:-

All those certain pieces, parcels or lots of land near the City of Greenville, in the County of Greenville, State of South Carolina, on the Northeast side of Brookway Drive, being known and designated as Lots Nos. 19 and 20, Block "C", as shown on a revised map of Grove Park made by W. J. Riddle, April, 1939, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book J, pages 68 and 69, and having, according to said plat the following metes and bounds, to-wit:-

BEGINNING at a point on the Northeast side of Brookway Drive, joint corner of lots Nos. 18 and 19, and running thence with said Drive N. 60-03 W. 8.3 feet to an iron pin; thence still with said Drive N. 39-33 W. 42.6 feet to a point, joint corner of lots Nos. 19 and 20; thence with the joint line of said lots N. 36-32 E. 193.1 feet to a point at the joint rear corner of lots Nos. 20, 21, 13 and 12; thence with the rear line of lots Nos. 13 and 14 S. 59-15 E. 50 feet to a point, joint rear corner of lots Nos. 18, 19, 14 and 15; thence with the joint line of lots Nos. 18 and 19 S. 36-32 W. 206 feet to the beginning corner.
