semi-annually until paid in full; all interest not paid when due to bear

BEGINNING at an iron pin on said Northeast corner of Crescent Avenue and Jones Avenue and running thence Jones Avenue in a Northerly direction 200 feet to an iron pin; thence in an Easterly direction parallel with Crescent Avenue 100 feet to an iron pin corner of lot now or formerly of Sweeney; thence with said Sweeney line in a Southerly direction 200 feet to an iron pin on Crescent Avenue; thence with said Crescent Avenue 100 feet to the beginning corner.
