C., immediately upon payment, until all amounts due under this mortgage have been paid in full, and should ~~X~~ We fail to pay said taxes and other governmental assessments, the mortgagee may, at its option, pay same and charge the amounts so paid to the mortgage debt, and collect same under this mortgage with interest.

And it is hereby agreed as a part of the consideration for the loan herein secured, that the mortgagor ~~S~~ shall keep the premises herein described in good repair, and should ~~X~~ We fail to do so, the mortgagee, its successors, or assigns may enter upon said premises, make whatever repairs are necessary, and charge the expenses for such repairs to the mortgage debt and collect same under this mortgage, with interest.

And ~~X~~ We do hereby assign, set over and transfer unto the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S.
