near National Highway from Greenville to Spartanburg, at site of former Camp Sevier, and being known and designated as Lots Nos. 6 and 22, as shown on plat of property of Gladys Greene Hack, made by W. J. Riddle, Surveyor, dated June 25, 1940, to be recorded, and having, according to said plat, the following metes and bounds, to-wit:
