

## TITLE TO REAL ESTATE

(g) The terms "herein," "hereby," "hereunder," "hereof," "hereto," "hereinbefore," "hereinafter" and words of similar import shall be held and construed to refer to this Indenture and not to a particular Article, Section or other portion thereof.

(h) References to Sections and Articles shall be understood to refer to Sections and Articles of this Indenture.

(i) No specific enumeration preceded or followed by general language shall be construed as restricting such general language. Any word in either number shall be construed to mean both the singular and plural

§14.08. All the covenants, stipulations, promises and agreements in this Indenture contained by or on behalf of the Company or of the Trustee shall inure to and bind their respective successors and assigns.

§14.09. Although this Indenture is dated for convenience and for the purpose or reference as of April 1, 1940, the actual date or dates of execution by the Company and by the Trustee are as indicated by their respective acknowledgments hereto annexed.

§14.10. This Indenture shall mature on April 1, 1955.

§14.11. This Indenture may be executed in several counterparts, each of which shall be deemed to be an original, and such counterparts shall together constitute but one and the same instrument.
