SEND GREETINGS:

WHEREAS I the said Ruth Hettie Bishop

in and by my certain promissory note, in writing, of even date with these presents well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of

TWO THOUSAND, FOUR HUNDRED & NO/100

(\$ 2,400.00) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in installments of

TWENTY-FOUR AND NO/100

\$24.00

Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for (10%) per centum attorney's fees besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in Greenville Township, in a subdivision known as Kanatenah, and being known and designated as Lot No. 1, of Block D, as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book F, at pages 66 and 67, (see also pages 130-131), and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the northeast corner of Oregon street and Mitchell street, and running thence along the line of said Oregon street, N. 63-35 E. 60 feet to an iron pin, joint corner of Lots 1 and 2, of Block D; thence along the joint line of said Lots 1 and 2, N. 26-30 W. 165 feet to an iron pin; thence S. 63-35 W. 60 feet to an iron pin on the east side of Mitchell street; thence along the line of said Mitchell street, S. 26-30 E. 165 feet to the beginning corner. Being the same lot conveyed to me by Irene Cline Moseley by deed dated Jan. 23, 1936 and recorded in the R. M. C. Office for Greenville County in Vol. 184, page 209."
