WHEREAS, the Mortgagor is well and truly indebted unto **Bank of Greenwood, Greenwood, S. C.**

organized and existing under the laws of **South Carolina**

called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **TWENTY-FIVE HUNDRED AND NO/100** Dollars (\$ **2,500.00**), with interest from date at the rate of **four and one-half** per centum (**4½** %) per annum until paid, said principal and interest being payable at the office of **Bank of Greenwood, in Greenwood, S. C.**

~~xxx~~, or at such other place as the holder of the note may designate in writing, in monthly installments of **NINETEEN AND 13/100** Dollars (\$ **19.13**), commencing on the first day of **December**, 19 **40**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **November**, 19 **55**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being on the Southeast side of Perry Road, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 8 on plat of property of L. A. Moseley made by Dalton & Neves, Engineers, June, 1940, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book J, at page 239, and having, according to a survey made by R. E. Dalton, November 12th, 1940, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Southeast side of Perry Road, joint corner of lots 8 and 9, said pin being also 199 feet in a Northeasterly direction from the point where the Southeast line of Perry Road intersects with the Northeast line of Charles Street (formerly known as Mountainview Court) and running thence with the Southeast side of Perry Road N. 43-15 E. 60 feet to an iron pin, corner of Lot No. 7; thence with the line of Lot 7 S. 46-45 E. 145 feet to an iron pin; thence with the rear line of Lot 14 S. 43-15 W. 60 feet to an iron pin; thence with the line of Lot 9 N. 46-45 W. 145 feet to an iron pin on the Southeast side of Perry Road, the beginning corner.
