NOW KNOW ALL MEN, That I, the said Mary A. Barbour,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. K. Townes, Attorney, his heirs and assigns

all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being known and designated as lots Nos. 6 and 7 of Block I, Sheet 22, according to the City Map on file in the County Auditor's Office, and having thereon, my residence and a tenant house. Said lots in the aggregate have the following metes and bounds, to wit:

BEGINNING at the southwest corner of Echols and Pinckney Streets, and thence running with Echols Street, southwesterly 113.7 feet to the corner of E. C. Brown lot; thence with line of E. C. Brown lot, southeasterly 100 feet to corner of Lena White's line; thence with line of Lena White's lot, N. 57-20 E. 117 feet to Pinckney Street; thence with Pinckney Street, northwesterly 100 feet to the beginning corner.

Said land was devised to me by my husband, B. H. Barbour, by his will on file in the Probate Office for Greenville County in Apartment 73, File 49, and conveyed to said B. H. Barbour by J. C.
