TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Alvin Watson, of the County of Greenville, State of South Carolina

SEND GREETINGS:

WHEREAS I, the said Alvin Watson

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of THIRTY TWO HUNDRED & NO/100

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of THIRTY TWO & NO/100 Dollars, (\$ 3200.00)

(\$ 32.00) Dollars upon the first day of each and every calendar month hereafter until the full principal sum with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said interest shall be paid in advance on the first day of each month; that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of thirty (30) days, or failing to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the lender hereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, the said Alvin Watson

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

D. Neves, C. E., March 28, 1924, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "F" at Page 204, and having, according to said plat, the following metes and bounds:

Beginning at a stake on the North side of Buist Avenue, at corner of Lot No. 18, which stake is 457 feet from the corner of Robinson Street, and running thence with the Northern side of Buist Avenue, S. 80-15 E. 100 feet to a stake, corner of Lot No. 20; thence with the line of said lot, N. 9-45 E. 170½ feet to a stake on a 19 foot alley; thence with the Southern side of said alley, N. 80-15 W. 100 feet to a stake, corner of Lot No. 18; thence with the line of said lot, S. 9-45 W. 170½ feet to the beginning corner; being the same property conveyed to Alvin Watson by John D. Smeak and Theresa H. Smeak by deed dated June 8, 1938, recorded in the R. M. C. Office for Greenville County, S. C., in Book of Deeds "204" at Page 154.
