TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, L. H. Bowen, of Greenville County, South Carolina,

SEND GREETINGS:

WHEREAS I, the said L. H. Bowen

in and by my certain promissory note, in writing, of even date with these presents, and well and truly indebted to FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of **ONE HUNDRED NINETY AND NO/100**

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of **FIVE AND NO/100** Dollars,

(\$ **5.00**) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal, said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

NOW, KNOW ALL MEN, That I, the said L. H. Bowen

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said L. H. Bowen in hand well and truly paid by the said FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. "BEGINNING at an iron pin at the Southeast corner of West Augusta Drive and Tomassee Avenue, and running thence with the Southern side of West Augusta Drive, S. 70-23 E. 86.3 feet to corner of Lot No. 56; thence with the line of said lot, S. 21-35 W. 163.9 feet to an iron pin in line of Lot No. 58; thence with the line of said lot, N. 71-35 W. 86.36 feet to a point on Tomassee Avenue; thence with the Eastern side of Tomassee Avenue, N. 21-35 E. 165.6 feet to the beginning corner; said premises being that conveyed to L. H. Bowen by Mary W. Leatherwood by deed dated October 18, 1934, and recorded in the R. M. C. Office for Greenville County in Book of Deeds "167" at Page 325.
