TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, R. E. Shoaf

Whereas, I the said R. E. Shoaf  
in and by my certain promissory note in writing, of even date with these presents,  
well and truly indebted to R. H. Parker

in the full and just sum of Two Hundred Ninety and no/100 (\$290.00)  
(\$ ) Dollars, to be paid

as follows: Thirty (\$30.00) Dollars to be paid on March 30th 1941, and the sum of Twenty-five (\$25.00) Dollars on the 1st day of July, 1941, and the sum of Twenty-five (\$25.00) Dollars on the 1st day of October, January, April and July of each year thereafter until the principal has been paid in full,

with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid quarterly

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain parcel, lot or tract of land situate, lying and being in Chick Springs Township, Greenville County, S. C., known and designated as the front portion of Tract No. 8 on plat of Arthur S. A gnew property known as Clairmont Ridge and having, according to said plat made by Dalton & Neves, Engineers, which is of record in the R. M. C. Office for Greenville County, S. C., in Plat Book "H", at page 182, the following notes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the southwest side of Piney Mountain Road, which iron pin is at the joint corner of Tracts 7 and 8, and running thence with the joint line of said tracts S. 43-00 W. 450 feet to an iron pin; thence on a new line across Tract No. 8, N. 42-40 W. 230 feet, more or less, to an iron pin in the joint line of Tracts No. 8 and 9; thence with the line of Tract No. 9, N. 47-20 E. 390 feet to an iron pin on the southwest side of Piney Mountain Road; thence with said Piney Mountain Road S. 56-00 E. 200 feet to the beginning corner.
