BEGINNING at spring branch on Gap Creek Road, thence S. 45 W. 4.50 to stone on East side of Gap Creek Road; thence S. 38 E. 19.50 to rock corner x; thence N. 45 E. 5 ch. to Chest. Oak x; thence N. 77 E. 6 chains Chest. O. X; thence N. 25 E. 5 chains to J. W. Mullinax corner; thence N. 28 W. 11 chains to Gap Creek Road at mouth of Big Branch; thence up Big Branch to Gap Creek Road; thence down and with Gap Creek Road to the beginning, containing thirty (30) acres, more or less.
