Charles, made by W. J. Riddle, Surveyor, April 30, 1936, containing 3.97 acres, and having the following courses and distances according to said plat.

BEGINNING at an iron pin, corner of Lot No. 6, heretofore conveyed to R. M. Kennedy, and running thence with line of said lot S. 31-20 W. 951 feet to iron pin in 10 foot road; thence with said road S. 65-15 E. 192 feet to iron pin, corner of Lot No. 4; thence with line of said lot N. 31-20 W. 872.3 feet to iron pin in White Horse Road; thence with White Horse Road N. 41-36 W. 200 feet to the beginning. Being the same tract of land conveyed to me by Cherry Investment Company by deed dated January 22, 1937 and recorded in the R. M. C. Office for Greenville County in Deed Book 194, page 8.
