(\$ 2702.01 ) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Thirty-two (\$ 32.00 ) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage, said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind.

C., the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Near the Augusta Road, being known and designated as Lot No. 62, Block D, as shown on plat of Augusta Court made by R. E. Dalton, Engineer, April, 1923, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book F at Page 124, and having in the aggregate according to said plat the following metes and bounds, to-wit:

Beginning at an iron pipe on the north side of a 50-foot unnamed street, joint corner of lots 60 and 61, thence along the dividing line of said lots N. 50-42 E. 154.2 feet to an iron pin, thence S. 39-18 E. 60 feet to an iron pin, joint northern corner lots 62 and 63; thence along the dividing line of said lots S. 50-42 W. 164.5 feet to an iron pin on said 50-foot unnamed street; thence S. 29-34 E. 61 feet to the point of beginning.
